## The President's Report

This report is an overview of the state of the association since our 18th FAPSA Conference in Cape Town 2019. It is also our report to the National Conference as we have converged here in Gold Reef City Theme Park Hotel in Gauteng, under the theme,

### #Empowering Futures: Fostering Inclusive Innovation in Financial Aid

It is an administrative and organisational account of developments of the period activities ensued and assessment of the progress made, and challenges faced by our association and our country at large. It outlines the major tasks of our association for the period ahead.

Our purpose remains serving the institutions and financial aid practitioners in the Education sector. However, our association is still tasked with a developmental agenda that seeks to broaden access to financial aid whilst also ensuring that students are not trapped in debt indefinitely. Therefore, this means, we need to take a closer look at the purpose and define what must become our attitude or the posture that we need to take or assume going forward.

### Colleagues,

As Financial Aid Practitioners South Africa (FAPSA) have noted the students protests over across several institutions in our public higher education system and recognises that all students, like all members of the society, have their constitutional rights to protest and voice their opinions and frustrations.

However, that should not be done through vandalisation of the government property.

Our institutions were once prescribed as fragmented in a fragmented state. The latter immediately suggested that a new dawn of fresh thinking and approach need to be provided hence we witnessed the merging of institutions to enable a unison approach in the sector of learning.

However more than two decades later inequality is still predominant, and we have recently more than once experienced scenes which should remind us



of our twin task as an association and active citizens.

The Department of Higher Education and Training (DHET) through NSFAS has allocated billions for needy students across institutions of learning, however the unrests in institutions suggest that this is not adequate hence the spontaneous unrest which engulfed our institutions across the country. This was not just peaceful unrests, but they have been coupled with serious damage to property to the detriment of the relative peace and tranquility we enjoyed previously.

We have previously demanded adequate participation in the board of NSFAS, will such a move bring about change in the board? Can we stand in unison in support of our claim that such will assist in bringing about change and adequate funding? Is it through our participation in the board that such challenges can be minimised?

I am in no way trying to scorn our resolve but the current developments demand of us to ask these critical questions in response to the national question of adequate funding and transformation. Ours is a development role however we shall not meet our core objective if we do not go beyond the call of duty and be party to the transformation agenda in this country.

The state has increased NSFAS funding however it is impossible even with that increase to meet the high demand. Some institutions can barely survive without this state intervention nor meet the student's needs. The quagmire is not new to all of us. Some in our quarters were quick to degenerate the debate by claiming the hand of the unseen third force and by so doing they deliberately misled the country from discussing this matter without being sidetracked. We should dismiss such acts because surely, we are in unison when we say we are confronted by high level of inequalities in South Africa.

We have further neglected the role of other bursary schemes in easing and eradicating the pressure we are confronted with in our institutions. We must seek audience with diplomatic mission in this country and familiarise ourselves with their work for the benefit of our institutions.



### Our association was confronted with the following:

- The advent of COVID-19
- Change of signatories took longer than expected
- Resignation of the SG because of promotional career path
- Resignation of the TG
- President promoted to the Deputy Principal Registrar
- Mr Boston, the exco member, was promoted to the Campus Manager
- New administration of NSFAS

We had a limping exco based on the challenges that we have articulated.

President Thabo Mbeki once said,

"Gloom and despondency has never defeated adversity; we should never be despondent because the weather is bad, nor should we turn triumphalist because the sun shines. Trying times require courage and resilience, our best of character is not tested during difficult and trying times".

On behalf of the outgoing executive committee of whom I presided over, I want to take this golden, wonderful opportunity to express my words of gratitude to the general membership of FAPSA and affording us an opportunity to lead you.

We further want to wish the incoming leadership all the best of luck and it is indeed our conviction that they will lead this association in accordance with our ideals and aspirations.

# **Secretary General's Report**

### Background information

This report intends to cover the period I was co-opted to the Executive. I must also reflect the challenge that we collectively encountered to retrieve the organisation information to provide a holistic account on the organisational performance. However, the summary covered on the period sketched while the missing information would be not much to determine the significant work done.

Since my inception as a co-opted Secretary General, the information captured in this report intends to posture association's strength and weaknesses in the post covid-19 era. As we all know, we are living through unprecedented times.

The Executive Committee has had to carry out its constitutional obligations during this period and has managed to do so in turbulent times. While more could have been achieved as alluded, especially in terms of the envisaged plan of action proposed and developed by members, concrete steps were taken to keep FAPSA alive and working during the pandemic.

It is in this context that this report symbolises an association that is growing but still require an indepth agenda setting for in line with the challenges faced by the national funding scheme and PSET sector in bordering access through a transformed NSFAS funding that is responsive to the material conditions of students.

However, the vacuum was never allowed as members were co-opted to fill the vacancies as they exist during the period under review. #### Narrative on vacancies filled and operational constraints

- In the interest of transparency and embedding a notion of openness, it is important for this AGM to note the following movements that affected the membership of the Exco and association's operational constrains.
- Ms Mohlala became the acting Secretary General in November 2022 after Ms D Nemakhavhani resigned. As the organisation, we extend our gratitude to Ms Nemakhavhani for dedication during the period she spend in the Exco in the period under review.
- In 2023, the Executive Committee struggled to function after the resignation of Ms Makgae, Treasurer General due to personal circumstances. The remaining Executive Committee was compelled to co-opted Ms N. Khauoe (SG), Ms G Ihenacho (TG) and additional members to the committee Mr Sauls and Mr Aphane to fill the vacant positions.
- The hand over has not been an easy process and lots of fixing of our administration emanating from the past so that we have an association with solid process and procedure as an established organisation.
- The Executive Committee met regularly in constructive and productive meetings in the preparation of 2023 FAPSA 19 Conference in July 2023. The FAPSA engagements with institutions and NSFAS meetings were mainly held online via Microsoft Teams, following the implementation of lockdown protocols. Minutes of all the meetings are available from the secretariat on request.



### Concluding remarks

FAPSA, since 2001, has always played a pivotal role in determining what the Best Practices and Processed would be in assisting Financial Aid Offices, and in assisting NSFAS and Donors alike in the management, administration, and allocation of funds within the industry.

The past few years turned out to be some of the most challenging years within the industry since the inception of FAPSA. As Exco hoping that there will be much more constructive engagements with stakeholders on funding in general especially with NSFAS where we can find better solutions and reshaping of our processes for the benefit of all parties.

We were also hoping that NSFAS regards FAPSA as key stakeholder and forefront of funding matters and convene quarterly meetings and build the communication. It is expected that the next term would focus on the association's renewal and invest on strategies that would be an allay in the PSET sector and reconnect with NSFAS at the level of the board. This is necessary for re-establishing the association influence through effective professional voice for the student funding in PSET sector.

## The Treasurer's Report

#### Annual Financial Statements

The Annual Financial Statements are currently outstanding for the financial years ending 2019, 2020, 2021 and 2022. FAPSA financial year end is on the 31 December 2023. In the past it would seem we were heavily reliant on external auditors and therefore the challenges with the handover have caused the delay in the financial reporting.

The association has a healthy cash flow even though we have not received any income since 2019. During 2020 there was a conference planned which had to be cancelled due to covid. There was a deposit of R100 000.00 that was paid to secure the venue. There was no payment received from delegates after registration. The refund from the venue was received. The bank balance when I was coopted in the Executive Committee was R524 855.09.

When we were co-opted, we discovered the following lapses in legislation compliance:

- The association is not registered for tax exemption with SARS and therefore does not have a PBO number
- Tax returns not done since 2016
- Handover of access to the bank account
- Unavailability of company registration
- Changing of Directorship from the CIPC
- Unresponsive auditors



We will need to implement remedial actions to prevent these issues from occurring in the future. The remedial action will include but not limited to:

- Setting up an office for administrative and finance (recommendation: appoint a permanent administration and have a permanent virtual office)
- Appointing an accounting firm to assist with financial administration and backlog in financial reporting
- Reduce the requirement in constitution from audit to independent review
- Start collecting membership fees at the beginning of the year to assist with the running of the administrative office
- Amend the constitution to allow for a smooth handover to the new EXCO
- Apply with SARS for tax exemption and catch up on the tax returns for prior years
- Start working on alternative revenue stream (eg, engagement events with FAPSA stakeholders)

These remedial actions will assist FAPSA to produce timeous reports for member perusal and increase transparency and accountability to its members. The financial reports should be posted on the FAPSA website as and when they become available.



### Members,

I am happy to announce that even though we were unable to secure sponsorship for the 19th FAPSA Annual Conference, as off today the conference is financially profitable that will be reflected on the financial report for the year ending 2023.

I wish to express gratitude to the outgoing EXCO for trusting me with such a mammoth task. We might not have been to achieve what others expected of us but at least we were able to bring members together once more. Me thank you's would not be complete if I did not mention the former Treasurer General for her support.
